## ⋄ ⋄ ⋄ ⋄ ⋄ ⋄ POOL RULES ⋄ ⋄ ⋄ ⋄ ⋄ ⋄

### Pool Capacity: 22 persons

- The pool area is reserved for the exclusive use of Ridgecrest residents only – GUESTS MUST BE ACCOMPANIED BY AN ADULT RESIDENT.
- The POOL GATES are to be kept LOCKED at all times.
- GLASSWARE OF ANY KIND (including bottles, ashtrays, glasses, etc.) is STRICTLY PROHIBITED in the pool area.
- CONDUCT WHICH IS RESPECTFUL of other pool users and of pool property is required at all times. No loud music or disruptive behavior allowed.
- Music players are allowed **ONLY WITH EAR PHONES**, except that at a prearranged, preapproved party, the Board of Directors may authorize, in writing, music to be played at a restricted level for a restricted time period.
- No diapered individuals are allowed in the pool without approve swim wear. Subject to State and Local Health and Safety codes.
- Unsupervised children under 14 are prohibited. All children under 14 must be supervised by an Adult Resident.
- NO PETS are allowed inside the pool area.
- There shall be no loud or boisterous conduct, “horse playing”, or running in or about the pool or pool area or spa. No jumping diving or splashing of any kind, inner tubes, floatation devices, beach balls, etc. are not allowed in the pool, pool area or spa.

### Spa Capacity: 6 persons

**CAUTION SPA USERS!! NO CHILDREN UNDER THE AGE OF 14 ALLOWED IN SPA.**

- Elderly persons, pregnant women, infants and those with health conditions requiring medical care should consult with physician before entering spa.
- Hot water immersion while under the influence of alcohol, narcotics, drugs or medicines may lead to serious consequences and is not recommended.
- Do not use alone.
- Long exposure may result in nausea, dizziness or fainting.
- Spa Cover to remain in place when Spa is not in use.

For a complete list of rules, please refer to the Association CC&R's, Rules and Regulations. The Board of Directors reserves the right to impose monetary fines and/or suspend pool privileges if repeated violations occur.
